On January 18 drilled 295'. Set 9-5/8, 32.30, and cement with 150 sx. of regular cement. Cement circulated. WOC 24 hrs., drilled out, tested for water shut off, which was satisfactory. Drilled to 3115, set and cemented 7", 26#, at 3115'. Cemented with 100 sacks cement. WOC 48 hrs., tested pipe at 1000#, drilled out to TD 3127.
