On December 29, 1954, drilled to 3099', 7" 26# used, set at 3096 with 100 sx. cement. Pipe was tested at 1000 lbs. for 30 minutes, no decline in pressure observed. On January 4, 1955, drilled out to TD of 3110, top of Queen Sand encountered at 3097', 2500' of oil rose in hole, unable to bail down. 2" 8Rd EUE tubing landed at 3000'
