Run 15 sack cement plug at 1350' @ top of anhydrite.
Run 15 sack cement plug in and out of 12-3/4" surface csg. @ 302'.
Run 5 sack cement plug at surface.
Erect properly inscribed 4"x8" pipe marker and make location cleanup.
