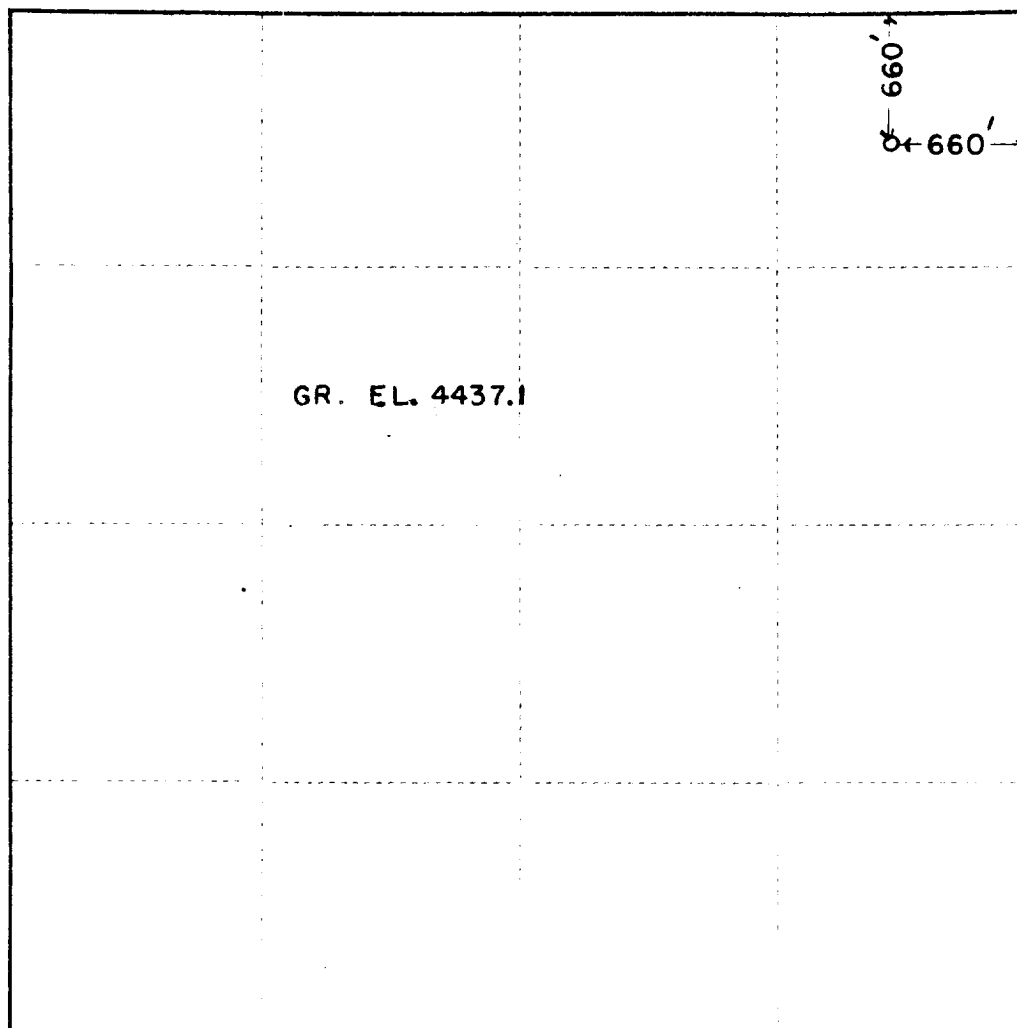
WELL LOCATION SURVEY PLAT
