FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Intend to clean well out with cable tools to TD, run gamma ray and caliper logs, plug back with gravel to top of pay, set calseal plug in anhydrite zone immediately above pay, set and cement approximately 125' 4½" OD 12.6# Hydril FJ liner extending into 5½" casing, let cement set, test for shut off, drill out plug and sand pump gravel to TD.

Following liner work intend to treat well by the sand frac process using 7500 gallons of lease crude and 15,000# 20-40 mesh sand and put well back on pump.
