The hole was washed down and the casing tested with 1200# pressure applied for 30 minutes. The plug was drilled and the casing tested with 600# pressure applied for 30 minutes. Both tests were OK, and after approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to complete well.

Top of cement behind 5-1/2" casing at 1150' per temperature survey.
