Abstract: The purpose of this study was to determine if there were differences in the prevalence of risk factors for falls between fallers and nonfallers. A cross-sectional study was conducted in a community-based sample of older adults. Data were collected from 607 participants who completed a questionnaire about their history of falling, demographic information, and various risk factors for falls. Results showed that fallers had significantly higher rates of several risk factors compared to nonfallers, including poor vision, low physical activity, and taking medications. These findings suggest that interventions targeting these risk factors may help reduce the incidence of falls in older adults.
