Great Western Drilling Co. plans to plug and abandon well 13-14 as follows:  
Load the hole with 10# mud. Place a 25 sack plug of cement at the top of the Queen Sand (3037'). Pull some 1500' of 4 1/2" casing and place a 25 sack plug in the stub (about 1500'). Place a 25 sack plug at 278' in the shoe of the surface pipe and 10 sacks at the surface.
