On 5-24-70 ran tubing and set 25 sack cement plug at 3,042'. Pulled 40 joints of tubing and shut well in overnight; plug held OK. Loaded hole with mud and pulled 1,199' of 5-1/2" casing. Set 25 sack cement plugs at 1,199' and 302'. Set a 10 sack cement plug and marker at surface. Plugging operations completed 5-27-70.
