Temporarily abandoned in August of 1974.

Request permission to plug and abandon Well No. 2214 (W.I.) due to offset producers cutting high percentages of water, which is not economical to produce.

Proposed plugging procedure is as follows: Note - Mud laden fluid will be used between all plugs.

- (1) 100' cement plug @ bottom.
- (2) 100' cement plug @ stub of production casing cut. *100' Plug @ top of blng of Sect if exposed*
- (3) 100' cement plug @ surface casing shoe.
- (4) 10 sx cement plug @ surface
- (5) Steel marker, 4" dia. set in concrete w/4' above GL with lease name, well #, location, unit letter, section, township and range.

Notice will be given when final cleanup has been made and location is ready for inspection. **NOTIFIED 24 HOURS PRIOR TO THE BEGINNING OF PLUGGING OPERATIONS FOR THE C-103 TO BE APPROVED.**

Proposed plugging date is Dec., 1975.
