WELL LOCATION SURVEY PLAT

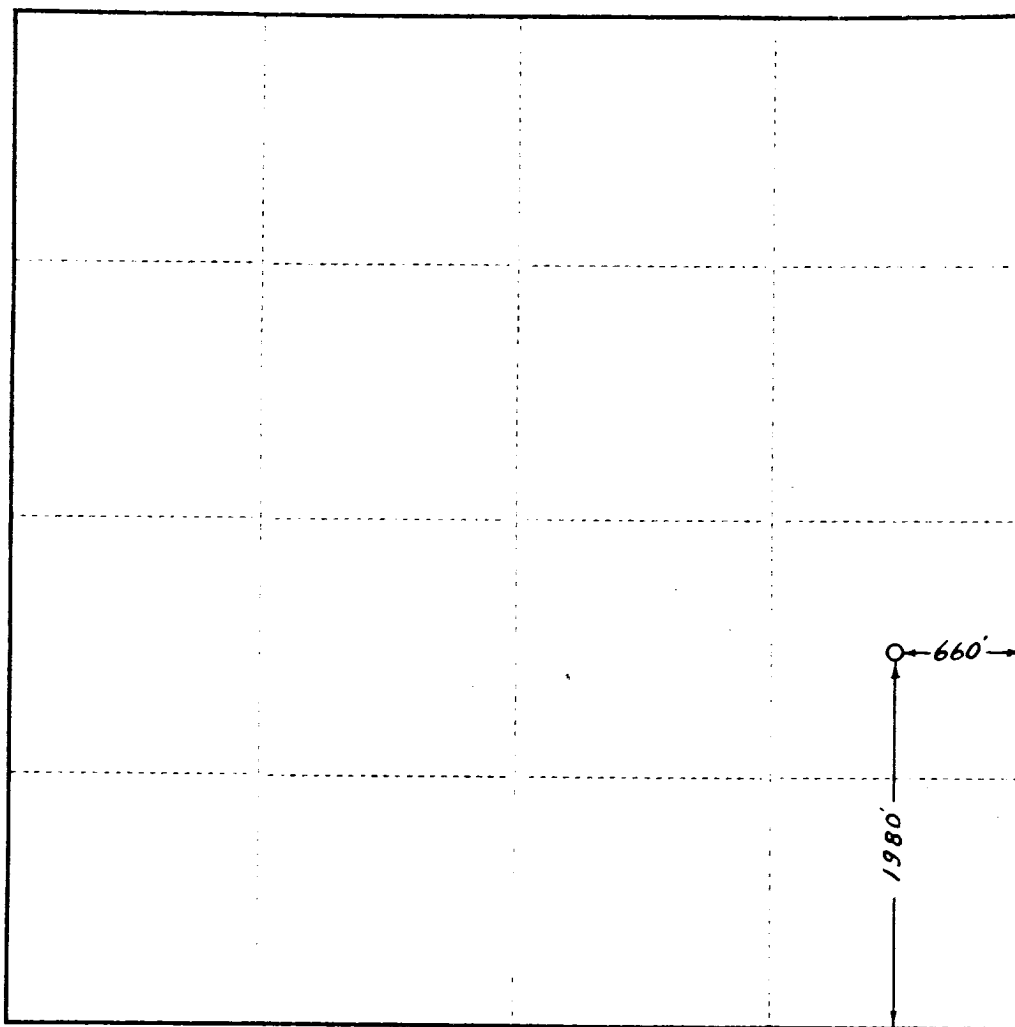
