Temporarily abandoned in December of 1972.

Request permission to plug and abandon the well, due to offset producers cutting high percentages of water, which is not economical to produce.

Proposed plugging procedure is as follows: Note - Mud laden fluid will be used between all plugs.

- 100' cement plug @ bottom.
 - 100' cement plug @ stub of production casing cut.
 - 100' cement plug @ surface casing shoe.
 - 10 sx cement plug @ surface.
 - Steel marker, 4" dia. set in concrete w/4' above GL with lease name, well#, location, unit letter, section, township and range.
- 100' plug @ top of 1st m of salt if 4' Dozed.*

Notice will be given when final cleanup has been made and location is ready for inspection.

Proposed plugging date is December, 1975.

THE COMMISSION MUST BE NOTIFIED 24 HOURS PRIOR TO THE BEGINNING OF PLUGGING OPERATIONS FOR THE C-103 TO BE APPROVED.
