Ran 9 1/2 Jts and out jt (3035') 4-1/2" OD 9.50# Gr H-40 SS casing. Set and cemented at 3041' with 75 sacks regular Neat cement. Plug at 3005'. Maximum pressure 700#. Job complete by Howce 2:AM 6-11-55.

After waiting over 30 hours, tested 4-1/2" casing with 800# for 30 minutes. No drop in pressure. Drilled cement plug from 3005' to 3041'. Tested below casing shoe with 400# for 30 minutes. No drop in pressure.
