DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 93 Jts and out jt (3014') 5-1/2" OD 14# Gr J-55 SS casing. Set and cemented at 3021' with 1400 sacks 4% Gel and 150 sacks Neat on bottom. Plug at 2986'. Maximum pressure 1100#. Circulated approximately 50 sacks cement. Job complete by Howco 8:30PM 2-3-55.

After waiting over 30 hours, tested 5-1/2" casing with 1000# for 30 minutes. There was no drop in pressure. Bailed 5-1/2" casing dry. Drilled plug from 2986' to 3021'. Bail tested 5-1/2" casing for 2 hours. No recovery.
