Ran 8 Jts (301') 8-5/8" OD 24# Gr J-55 SS casing. Set and cemented at 312' with 300 sacks Regular Neat cement. Plug at 297'. Maximum pressure 200#. Circulated approximately 75 sacks cement. Job complete 4:15PM 1-26-55.

After waiting over 24 hours, tested 8-5/8" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled plug from 297-312'. Tested below casing shoe with 400# for 30 minutes. No drop in pressure.
