Spudded February 7, 1955.

Ran 122' of 13-3/8" Spiral Weld and 120' of 13-3/8" 53# Seamless casing for a total of 242'. Set at 250', cemented with 250 sacks of Neat and circulated 15 sacks. Tested pipe and casing seat with 800# for 30 minutes before and after the drilling out of the cement on February 9, 1955, and both held OK.
