DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Total Depth, 3005' Anhydrite. Ran 97 joints 3002', 5½" OD casing set at 3004' and cemented with 300 sacks of cement. Plug was down at 8:45 A.M., July 31, 1954. Satisfactory casing shut-off test was made after allowing cement to set 48 hours. Top of cement by temperature survey was 2000'. Drilling was resumed.
