Total Depth 328' Red Bed. Ran 322' of 8 5/8" OD casing consisting of seven joints of 22.7# SW SJ casing and one joint of 24# 8R J-55 SS Casing set at 328' and cemented with 175 sacks of cement. Cement circulated. Plug was down at 10:00 P.M. July 23, 1954. Cement was allowed to set 24 hours before testing for shut-off. Test was satisfactory. Drilling resumed.
