Ran 99 Jts and out jt (3058') 5-1/2" OD 14# Gr J-55 SS casing. Set and cemented at 3066' with 1400 sacks AS Gel and 150 sacks Neat on bottom. Plug at 3031'. Maximum pressure 1000#. Circulated approximately 35 sacks cement. Job complete by Howe 8:15PM 1-31-55.

v After waiting over 30 hours, tested 5-1/2" casing with 1000#. There was no drop in pressure. Drilled cement plug from 3031' to 3066'. Swabbed 5-1/2" casing dry. Bail tested 2 hours. No recovery.
