DETAILS OF WORK

Total Depth 3042' Anhydrite. Ran 89 1/3 joints 3035' 5 1/2" OD 14# casing set at 3042 and cemented with 300 sacks. Plug was down at 12:20 P.M. October 1, 1954. Cement was allowed to set until October 5, 1954 while the rotary was moved off and cable tools moved in. Shut-off test was made and was satisfactory. Drilling was resumed.
