- 2-9-62 Rig up pulling unit, pulled cement lined tubing.
2-12-62 Ran Wright Survey's Flow Meter. 80% of injected water going out of well bore @ 2781' (5 $\frac{1}{4}$ " casing shoe @ 2781') & 20% was going into the top of the pay section.
- 4-2-62 Drilled 2799' to 2815' (KIM 6' above ground level)
4-3 & 4 Under reamed open hole interval 2781' to 2813' with Brown hydraulic under reamer.
- 4-5-62 Ran 40'3" of 3" API blk. 7.7# 800# Test line pipe for liner, set @ 2763' to 2815', cemented w/35 sacks reg. neat cement.
- 4-9-62 Ran tbg. to abrasijet perforate, could not get into liner.
4-10-62 Drilled cement out of liner, went in hole with jet tool.
Abrasiject perforated @ 2795', lost circulation and could not cut any more holes.
- 4-20-62 Ran tbg., circulated, and put back on injection.
5-1-62 Attempted to run Lane Wells Tracer Log, could not get to TD.
5-30-62 Circulated hole and ran Lane Wells Tracer, found fluid going out perforation and up the hole.
6-1-62 Squeeze perfs. @ 2795' w/75 sacks reg. neat + 2% HA-5, did not squeeze. Try again w/75 more sacks reg. neat + 2% HA-5.
Ran tbg. to drill out cement.
6-8-62 Pressure up before drilling out, would not hold pressure, pull tubing, go back open ended to squeeze.
6-9-62 Squeeze with 150 sacks reg. neat + 112# HALAD-9
6-11-62 Ran tbg. tagged cement. Drilled cement.
6-12-62 Drilled out to 2815'. Pressured up to 1,000#. Pressure held.
6-13-62 Went in hole with Abrasiject tool, could not get to TD
6-15-62 Cleaned out well bore.
6-19-62 Ran tubing and abrasijet perforated 2794:2792':2790':2788' w/ 2 holes per setting. Put well back on injection.
