We propose to drill a Queen Sand test to an approximate total depth of 2875 feet. Rotary will be used from top to bottom.

Approximately 130 feet of 4 5/8" surface casing will be run and cemented with 75 sacks.

The oil string, 4 1/2" casing, will be run to an approximate depth of 2840 feet and cemented with 125 sacks.

All casing will be run and cemented using methods approved by the U. S. Geological Survey.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
