We propose to temporarily abandon this injection well due to a rise in injection pressure which prohibits injection of water under our system design. The static tubing pressure is 500# and well will not flow down. The following is proposed:

1. Pump 50 sacks cement down cement lined tubing
2. Displace cement in tubing with 5 barrels water.
3. Shut in tubing.

WELL DATA: TD2796' , Open Hole 2775-96' , 5 1/2" csg @ 2775' w/100 sz, 13-3/8" csg. @ 90' w/50 sz. ; 2-3 Haliburton tension pkr @ 2252' on cement lined tubing.
