DETAILS OF WORK

I plan to drill a 2760' Queen sand test, using combination tools. I expect to drill to the 5 1/2" casing point with rotary, and drill in with cable tools.

3-5/8" surface pipe will be set at 90' with 50 sacks, which will circulate to the surface.

The 5 1/2" oil production string will be set in the Anhydrite cap overlying the Queen pay sand at approximately 2740' with 100 sacks.

All casing will be run and cemented under conditions approved by the U. S. Geological Survey.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

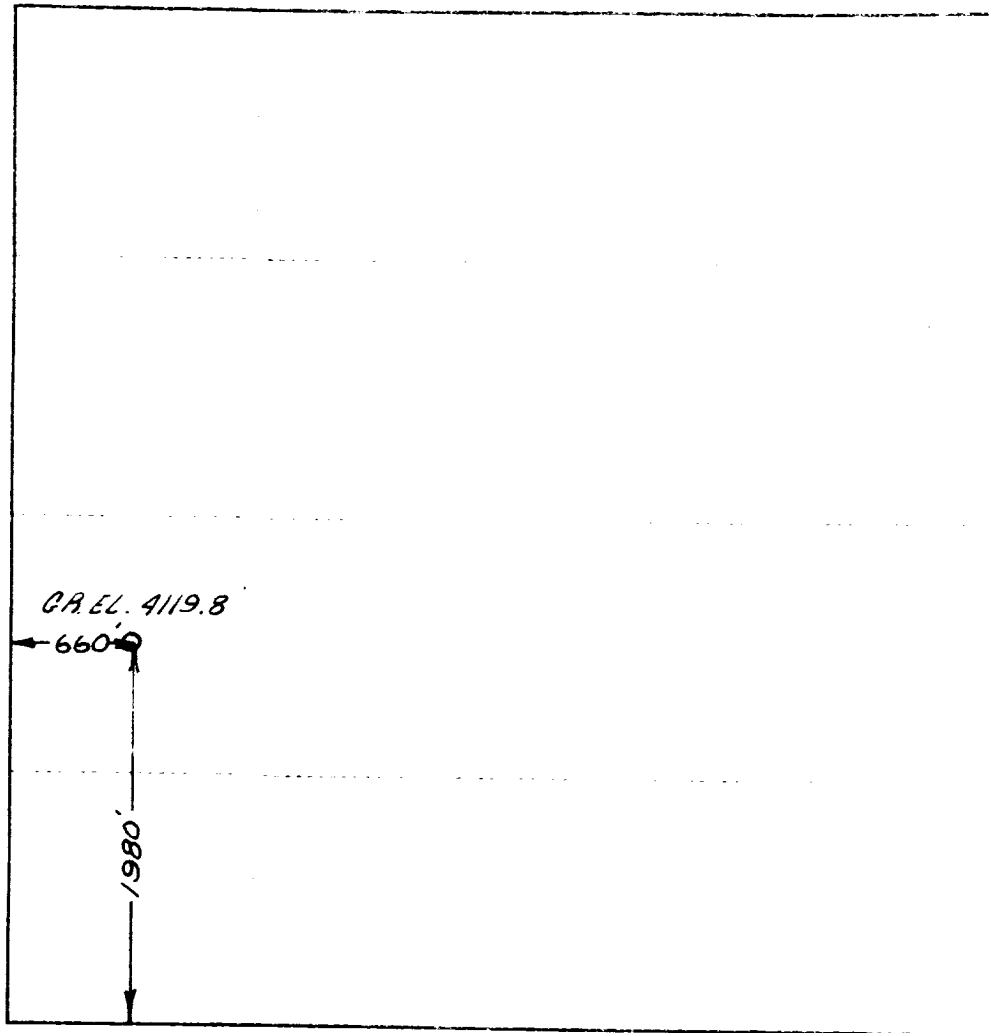
