DETAILS OF WORK

May 2, 1963 - Move in well service unit and clean out well bore to total depth of 2739'.

May 3, 1963 - Ran 2601' of 2-3/8" EUE 8rd. 4.79 1-55 Sals. Cement Lined tubing with a Guiberson "shorty" tension packer set at 2602'. Loaded the annulus with fresh water (300 of Sodium Bisulfate added) and pressured to 4000. Packer did not leak.

May 8, 1963 - Hooked up injection manifold and began injection as per New Mexico Oil Conservation Commission Order 2-2470. Have established an injection rate of 400 barrels per day.

I understand that this plan of work must receive approval in writing by the Geological Survey before operation is commenced.
