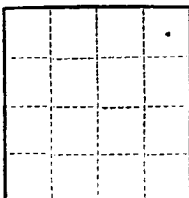

DETAILS OF WORK

T.D. 3040' Anhydrite. Ran 96 9/10 joints 3037.96' of 5 1/2" OD 14# 80 J-55 SC Casing set at 3040' and cemented with 150 sacks of regular cement. Mixed 15 sacks of aquagel with 75 barrel of water and pumped ahead of cement. Plug was down 6:30 P.M. June 17, 1954. The 8 5/8" OD 24# 80 J-55 SC Casing was reclaimed. Cement was allowed to set approximately 60 hours before testing for shut-off. The hole was bailed dry and no fluid entered the 5 1/2" casing during a 30 minute period and test was satisfactory. Drilling resumed.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
