Effective 12-1-60 this well was cleaned out and the following pumping equipment was installed: 1- type K 7"x2" tbg head, 1 - size 57 pumping unit, 1 - 7½ HP electric motor, 1 - 2"x1½"x12' insert pump, 116 - 5/8"x25' P&P sucker rods with 14' of pony rods for a total rod string of 2914', 1-jt 2" EUE 8R tbg 31.05', 1 - 2" EUE 8R seating nipple 1.10', 95-jts 2" EUE 8R tbg 2938.28' set @ 2970.43'.


