Ran 93 Jts and cut jt (3049') 7" OD 20# Gr J-55 SS casing. Set and cemented at 3056' with 1340 sacks 4% Gel and 150 sacks Neat on bottom. Plug at 3021'. Maximum pressure 800#. Job complete by Howco at 8:45AM 10-7-54.

After waiting over 30 hours, tested 7" casing with 1000# for 30 minutes. There was no drop in pressure. Bailed hole dry. Let set for 3 hours. No fill up. Drilled plug from 3021' to 3056'. Bailed hole dry. Let set for 3 hours. No fill up.
