1. Pull rods, pump and 2-3/8" tubing.
2. Run steel line measurement. Clean out with sand pump if necessary.
3. Treat open hole from 3067-3082' with 20,000 gallons lease oil containing Adomite with 1# sand per gallon.
4. Rerun rods, pump and 2-3/8" tubing.
