DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 93 Jts and cut jt (3059') 7" OD 20# Gr J-55 SS casing. Set and cemented at 3067' with 1500 sacks 4" Gel and 150 sacks Neat on bottom. Plug at 3031'. Maximum pressure 700#. Circulated estimated 75 sacks cement. Job complete by Howco 3:30PM 10-19-54.

After waiting over 30 hours, tested 7" casing with 1000# for 30 minutes. There was no drop in pressure. Bailed hole dry. After 24 hours, bailed hole. There was no fluid recovered.
