Ran 9 Jts (293') 9-5/8" OD 32.30# Gr H-40 SS casing. Set and cemented at 304' with 225 sacks Regular Neat cement. Plug at 284'. Maximum pressure 200#. Circulated approximately 20 sacks cement. Job complete by Howco 8:AM 12-15-54.

After waiting over 24 hours, tested 9-5/8" casing with 1000# for 30 minutes. No drop in pressure. Drilled cement plug from 284' to 304'. Tested below casing shoe with 400# for 30 minutes. No drop in pressure.
