A hole has been found in the 7" casing about 90' from surface. It is proposed to repair the leak with a stressed steel-plastic type patch.

It is also proposed to fracture well with 20,000# sand, 20,000 gal oil and 100# phosphate. It is believed this type of work will increase the oil production 150 bbls. per day. This well is open hole from 3047' to 3060'.
