Subject well was plugged 5/21/70 by Cities Service Oil Company by setting cast iron bridge plug 2967 cased with 25 sacks cement and a 10 sack plug at surface.

It is proposed to re-enter, shoot off 7" casing @ 2000, spot 100' plug across casing stub, 100' plug across top of salt at 1500, 100' plug across 12 3/4" casing shoe at 288, 10 sack plug at surface. In this manner 2000' of 7" casing will be recovered and the well more properly plugged to protect surface water.
