We propose to plug and abandon the above well in the following manner:

1. Set CI bridge plug in casing just above open hole. (7" set @ 3068 w/125 axs)
2. Set 25 sack cement plug on top of bridge plug.
3. Load hole with mud ladder fluid.
4. Set 10 sack cement surface plug with a 9" dry hole marker.
5. Clean location of all debris and equipment.
