This well was drilled to 2963' TD and completed as an oil well. As of 5-25-62 re-completed as a water injection well.

It is proposed to treat this well w/500 gal mud acid followed by 2000 gal acid nitrogen in order to increase the desired rate of water injection from 39 BPD to approximately 400 BPD which will permit greater operating efficiency of the waterflood system.
