This well was drilled to 173' in Red Bed. Ran 4 joints 160' of 8 5/8" OD 22.7# Armo SW SJ casing set at 173' and cemented with 100 sacks of neat cement. Cement circulated. Plug was down at 12:00 P.M. February 23, 1955. Cement was allowed to set 24 hours before testing for shut-off. Test was satisfactory. Drilling resumed.
