Ran 9 Jts (297') 9-5/8" OD 32.30# Gr H-40 SS casing. Set and cemented at 308' with 250 sacks regular cement. Plug at 285'. Maximum pressure 200#. Circulated approximately 40 sacks cement. Job complete by Newee 2:35AM 4-7-55.

After waiting over 24 hours, tested 9-5/8" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled cement plug from 285' to 308'. Tested below casing shoe with 400# for 30 minutes. No drop in pressure.
