Well spudded 8-1-55. Drilled w/rotary tools 12-1/4" hole to 178', reduced to 7-7/8" & drilled to 458' in redbeds. Ran 180.54' of 8-5/8" OD 24# 8rd thd J-55 casing set at 177.74' & cemented w/155 sx Longhorn portland. Cement circulated to surface. Tested casing before & after drilling cement plug w/500# for 30 minutes - no pressure losses.
