Ran 163' of 8-5/8" 28# Seamless H-40 casing and set at 175'. Cemented with 100 sacks of Neat and circulated 20 sacks. Tested pipe and casing seat with 800 psi for 30 minutes before and after the drilling out of the cement on May 4, 1955, and both held OK.
