Pipe set @ 415', Rotary measurements. Cemented with 400 sacks Eltora class "A" cement with 2% calcium chloride by Dowell. Plug down @ 10:00 A.M. 6-10-64. Release pressure. Pipe test 3:45 to 4:15 P.M. 6-11-64 Held 1000 psi. O.K. Start drilling 30 1/2 hrs. after cementing. Circulated cement outside casing with 80' cement inside. Drilled out cement from 335' to T.D. Drilling ahead 418' @ 5:00 P.M. 6-11-64.

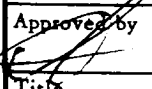
