We propose to plug and abandon this well in the following manner:

- 1. Set cast iron bridge plug @ 3505' and dump 35' cement plug on top.**
- 2. Cut 4-1/2" @ free point and spot 40 sacks on stub.**
- 3. Spot 35 sacks cement in and out of 8-5/8" surface casing @ 363'.**
- 4. Spot 10 sacks cement at surface.**
- 5. Install regulation dry hole marker.**
- 6. Clean up location.**
