Cactus Drilling Company spudded at 12:30 P.M. on 10-26-65 and drilled 11" hole to 360'. Set 8-5/8", 20# Ltd. Serv. Casing @ 351'. Cement with 200 ax. reg. cement w/2% Calcium Chloride and 1/4# gel flakes per sack. Circulate back 40 sacks cement. After W.O.C. for 20 hrs tested 8-5/8" casing & blow out preventers to 1000# for 30 Min. Test Okay.

Reduced to 7-7/8" @360' and resume drilling operations.
