Moved in Verna Drilling Company rotary tools. Spudded well at 8:00 PM 7/7/66. Drilled 12-1/4" hole to 380'. Ran 11 jts of 8-5/8" OD 8R 24# J-55 ST&C casing w/guide shoe & float collar = 361.56'. Set at 375.56' RKB. Cemented w/255 sx of Incor + 2% CaCl. Plug down @ 4:08 AM 7/8/66. Cement circulated. Tested 8-5/8" casing to 1000# for 30 minutes after 19-1/2 hours WOC. Casing OK. Resumed drilling = 7-7/8" hole.
