Ran and cemented 324.38' of 8 5/8" 24# and 20# casing and cemented at 336' with 100 sx 4% gel incor cement plus 100 sx 2% CaCl incor cement. Cement circulated. Cement in place at 5:25 AM, 7/16/66. WOC 24 hours. Tested casing with 1000 psi for 30 minutes. Tested okay.

Note: Encountered red beds at ground level.
