8-30-79: Ran 2 3/8" tbg & ppd 100 sx cmt to plug. Pld 2 3/8" tbg and 4 1/2" csg & ran 2 3/8" tbg to 1060'. Ppd 100 sx cmt plug. Pld 2 3/8" tbg to 315'. Ppd 50 sx cmt plug. Pld tbg & set plug in surface 8 5/8" csg. Cut off wellhead and marked location w/Am-co Federal #5, 1980' FSL and 1980' FWL, Section 33, T8S, R30E. Welded on 4' pipe. 4' above GR level.
