Moved in Permian Basin Casing Pullers, Inc. 8/3/78. Set last green bridge plug at 3350 and capped with 35' cement. Loaded hole with salt water gel mud. Shot and recovered 4 1/2" casing from 2528. Ran tubing and spotted 100' plug across 4 1/2" casing stub with 35 sacks cement. Tagged top of plug at 2460. Pulled tubing up to 1150' and spotted 100' plug from 1150 to 1050 across top salt. Pulled tubing up to 350' and spotted 100' plug from 350' to 250' across 8 5/8" casing shoe at 297 with 50 sacks cement. Spotted 10 sacks cement at surface and installed dry hole marker. Work complete 8/5/78.

Instructions
