Followed with 200 sacks Class "C", 1/4# Flo-seal, 2% CaCl₂. Cement was circulated to surface of ground. Job completed at 11:30 A.M., 7/31/72. Cut off casing, installed casinghead and BOP's. Tested pipe to 500 PSI, o.k.
