Read & Stevens is currently evaluating the potential for reconnecting the subject well to a low BTU gas line. The well produces a very low quality gas with a BTU content that ranges from 400 to 500. At the present time we are awaiting a proposal from the successor of Cabot Corporation which use to purchase the gas. As soon as a proposal is made to Read & Stevens concerning the price that can be paid for the gas, we will evaluate the property for return to production or plug and abandonment. During this process Read & Stevens requests the subject well be continued in a shut-in status until the purchaser's proposal is received.
