A shaffer type B, series 900 BOP will be used. If well is dry, it will be plugged according to NMOCC regulations, pits will be leveled, and 4' marker will be installed.

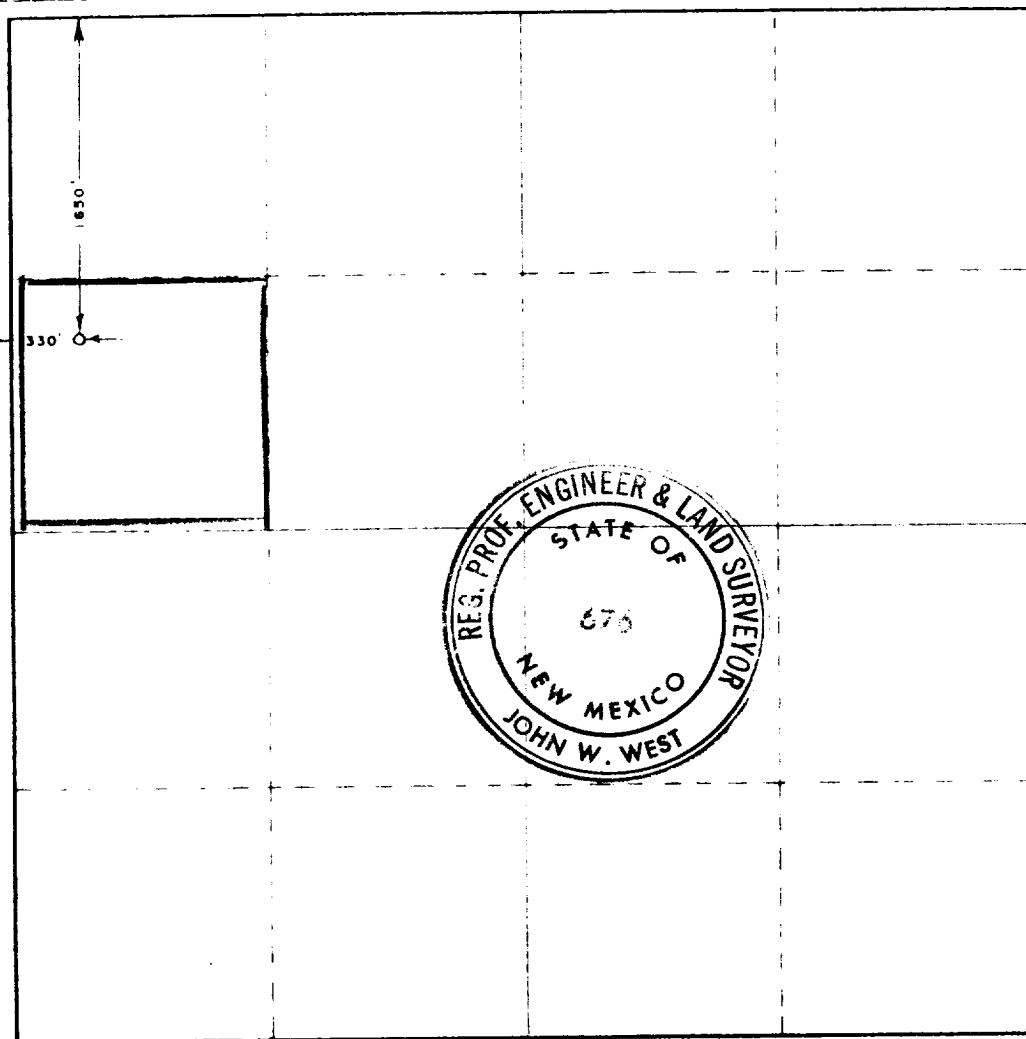
