Drill well with rotary tool to 375', set and cement 8-5/8" casing.
Install BOP, pressure test BOP and casing to 1000 psi
Drill well to 4450' or to sufficient depth to test the San Andres Formation whichever is less.
At total depth run electric and porosity logs. Run and cement production casing, if warranted by samples and logs.
Completion to be thru casing perforations with acid or frac treatment as necessary.

MUD PROGRAM: 0' - 375' Native mud with necessary additives to drill and cement 8-5/8" csg.
375' - 4450' Mud with necessary additives to drill and control lost circulation zones and to obtain good samples.

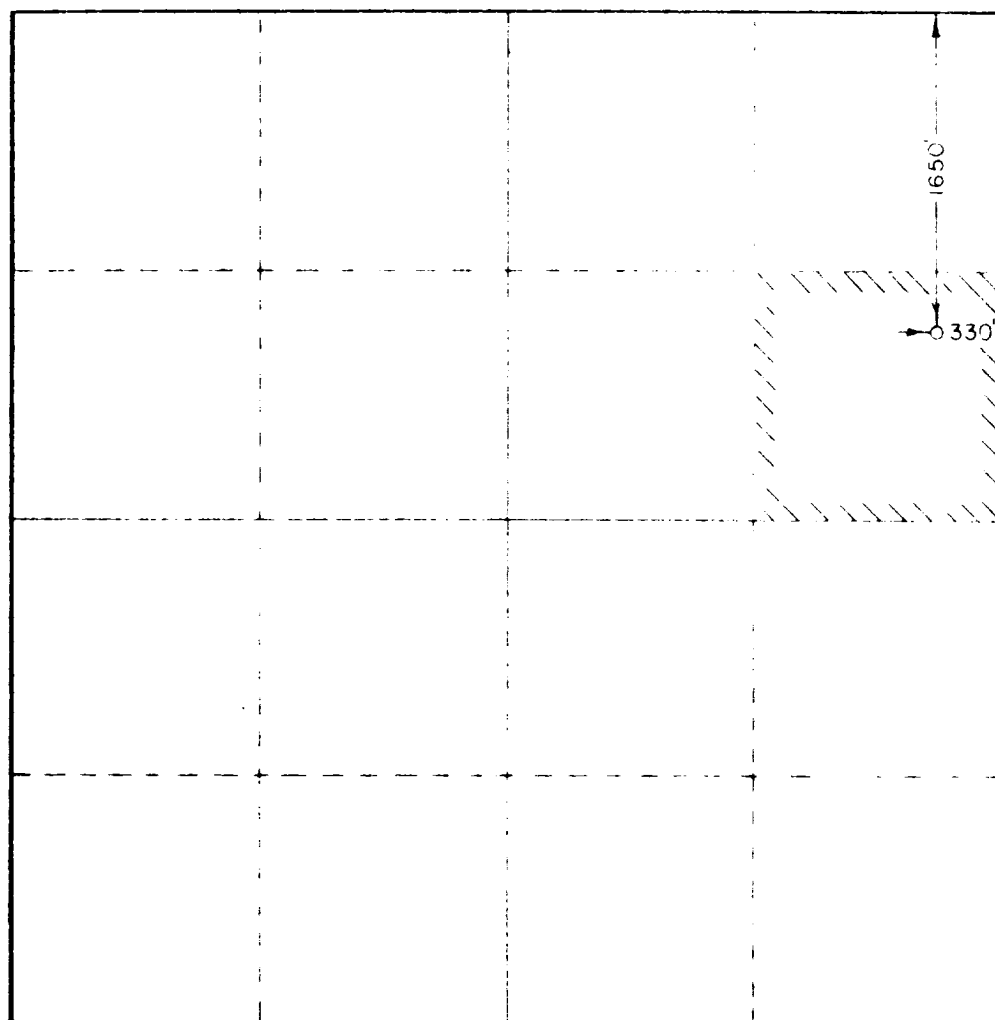
